V. CROWS LANDING INDUSTRIAL BUSINESS PARK UPDATE

County staff provided the Board with an overview presentation of the Crows Landing Industrial Business Park project. Project objectives include creation of a regional employment center to address historical unemployment rates, provide living-wage jobs, reduce out of county commute miles and vehicle miles traveled, and provide a concentrated reuse on the County's west side. The project would also optimize transportation infrastructure, offer large building sites and development flexibility. General land uses include light industrial, business park/professional office, logistics/distribution, public use airport/aviation compatible, public facilities/services, and green space/open space. The project phasing/buildout would be in three (3) phases with a 30—year timeframe. Updated information about this project can be obtained from the Crowsbizpark.biz website.

VI. STANISLAUS GENERAL PLAN AND AIRPORT LAND USE COMPATIBILITY PLAN UPDATE

Staff from the Planning Department provided the Board with an overview of an update to the Stanislaus County General Plan. This included updates to the following elements: Land Use, Circulation, Conservation/Open Space, Noise, Safety, and Agricultural. The purpose of the update is to incorporate changes in state law, and changes in local codes, standards and management plans and some minor language and formatting revisions. It also addresses Airport Land Use Compatibility Plan consistency. A handout was provided noting the summary of policy enhancements for each of these elements.

VII. ROOSTER ORDINANCE PROPOSED DEVELOPMENT

Staff from the Planning Department shared with the Board that they will be exploring an ordinance amendment relating to rooster limits on properties. Over the last few years, the County has received several complaints regarding both the number of roosters on properties, and illegal rooster fighting activities. Earlier in 2016, there was an illegal rooster fighting operation discovered where it was reported that there were over 300 live roosters found with an enclosed fence for fighting, and 50 dead roosters found on the property. The County zoning ordinance, which controls how land can be used, has *some* limitations on the number of rosters allowed, but the ordinance is limited. Planning will be forming a working group with different agencies to work on an ordinance amendment. The Board asked that county staff keep it updated on the ordinance development.

VIII. NOMINATING COMMITTEE RECOMMENDATIONS AND ELECTION OF OFFICERS

Ed Perry spoke on behalf of the nominating committee which was also comprised of Arby Hoobyar and Jim Mortensen. The committee met on May 2, 2016 to discuss the nominations and presented the following recommendations for nomination: Tom Orvis for the position of Chairman and Pamela Sweeten for the position of Vice-Chair. The floor was then open for additional nominations (none received) and a motion was made to accept the nominations and the vote was taken.

It was M/S/P (unanimous) that Tom Orvis be elected to Chairman of the Agricultural Advisory Board for the term July 1, 2016 – June 30, 2017.

It was M/S/P (unanimous), that Pamela Sweeten be elected as Vice-Chair of the Agricultural Advisory Board for the term July 1, 2016 – June 30, 2017.
