IV. WALNUT ORDINANCE SURVEY

The Ag Commissioner's office shared the results from a recent walnut theft ordinance questionnaire sent to the walnut growers in Stanislaus County. The survey shows that there is a substantial number of producers getting walnuts stolen each harvest

season. A large percentage of producers believe that roadside buyers and their customers are in need of further regulatory oversight. There seems to be a closer split between those who believe a new ordinance would or would not be of any help to control thefts. Also, a substantial number of those against an ordinance are opposed to any new regulations being passed. A copy of the walnut theft ordinance information shall be attached to these minutes.
