V. AGRICULTURAL ELEMENT OVERIEW – PLANNING DEPARTMENT

Staff from the Planning Department provided an overview of the Agricultural Element, which was first adopted in April of 1992. The primary purpose of the Ag Element is to promote and protect local agriculture through the adoption of policies designed to achieve three main goals: strengthen the agricultural sector of our economy; conserve our agricultural lands for agricultural uses; and protect the natural resources that sustain agriculture in Stanislaus County.

In 2007, a five-year review period was added. The next review update will be August 2021 and issues to be considered are lot line adjustment criteria (too specific for general policy document and the intent of the criteria is not clearly understood and is limiting in case specific situations with no impact to agriculture) and buffer and setback guidelines (alternative buffer provisions need to be based on objective standards that can be consistently applied or eliminated based on trend for allowing "no buffer" alternatives.

Additionally, there are two agriculturally related land use ordinance amendments: accessory dwelling units and farmworker housing.
